No port should be hidden for Cantt Board Bareilly specially 80 & 8080. The locations of server must be in India. Details of minimum requirements are as under :

- Window based VPS Server with 1 CPU Core, 2GB RAM 40 GB Storage and 1 Dedicated IP address.
- Hostname so that domain name can be pointed toward the dedicated IP to access the application with domain name. SMTP relay server name.
- Full permission to install necessary software like tomcat(latest), java (latest version), xampp.
- Full permission to Access/manage Server through Remote Desktop (RDP).

This VPS Server will be used to host the java/servlet/jsp based web application that can be accessed using domain name. It will be the responsibility of the services provider to configure the server with tomcat so that web application can be accessed with domain name (without transfer of domain name). Service provider will have to fix the all bug/error of operating system. The payment will be made on quarterly basis after satisfactory report by Computer Programmer, Cantt Board Bareilly. Qualifying bidder (L1) will have to submit Rs. 2500/- as security amount that will be refunded after satisfactory completion of period. Period of hosting will be 01 year that can be increased/decreased as per the requirement of Cantonment Board Bareilly. No license fee/any other charges will be paid to the agency/service provider separately for operating system. 
